**2008 Livestock Overnight Vehicle Admission Sticker & Auto Sticker Requests:** Requests for the livestock exhibitor-only parking area (Lots A, B, & C), will not be accepted prior to a postmark date of June 16 and MUST accompany a completed livestock entry form, with exceptions for 4-H Exhibitors and FFA Advisors, who may order without an entry form. NO vehicle sticker requests will be accepted prior to June 16; requests sent without an entry form or with a postmark prior to June 16 will be returned. **No orders will be accepted via telephone or e-mail; no orders accepted without payment (cash or check).** Stickers will be dated with the appropriate dates for when exhibitors will be showing. Fuel powered generators are prohibited in the overnight parking area. Please read the specific department premium book for complete details.

Exhibitors will be allowed to rent ONE overnight vehicle admission space AND/OR auto admission. Units that fit in a 10 x 20 foot area will require one sticker; larger units (up to 40 feet) will require the purchase of two stickers. **No vehicles over 40 feet in length will be accepted in the exhibitor overnight parking area.** These stickers are sold on a first come, first served basis. When the lot is full, no more stickers will be sold.

**Lots A and B.** These lots are used for the vehicle admission parking stickers. Vehicles will be parked in an area west of the Judging Arena. There will be two types of vehicle stickers sold for this area. For both stickers, the following rules apply: No units longer than 40 feet, vehicles with slide-outs must pay an additional \$20 per sticker. No units strictly used for storage. Purchase of these stickers will allow admission of the unit into the fairgrounds and allow for its parking in the above-specified area.

**Lot C.** During the FFA Livestock Show, this lot is used for cattle tie outs and overflow camping. No public parking will be permitted. Any vehicle without proper stickers will be towed at owner's expense.

When ordering stickers, you **must** submit the vehicle plate number the sticker will be placed on as well as the complete name, address & fair time contact information of the owner of the vehicle (i.e. cell phone number, if available). **If at anytime during the fair the vehicle's plate number does not match the information you have provided us, we reserve the right to revoke your sticker and your space.**

**Aug. 21 through Aug. 28:** Overnight Vehicle Admission sticker with electric hook-up, fitting into a 10 x 20 foot space, is \$80 (add \$20 if vehicle has a slide-out); larger vehicles fitting up to 10 x 40 foot space are \$140 for two stickers (add \$40 if vehicle has a slide-out). Overnight Vehicle Admission sticker without electric, fitting in to a 10 x 20 foot space, is \$60 (add \$20 if vehicle has a slide-out); larger vehicles fitting up to 10 x 40 foot space are \$120 for two stickers (add \$40 if vehicle has a slide-out). No vehicles over 40 feet in length will be accepted in the exhibitor overnight parking area. Auto stickers are \$40 (not for overnight parking). Exhibitors showing English Horses, Draft Horses, 4-H, Open Dairy Cattle, Open Swine, Open Sheep, Llamas, Poultry and Stock Dogs.

**Aug. 29 through Sept. 1:** Overnight Vehicle Admission sticker with electric hook-up, fitting into a 10 x 20 foot space, is \$70 (add \$20 if vehicle has a slide-out); larger vehicles fitting up to 10 x 40 foot space are \$120 for two stickers (add \$40 if vehicle has a slide-out). Overnight Vehicle Admission sticker without electric, fitting into a 10 x 20 foot space, is \$50 (add \$20 if vehicle has a slide-out); larger vehicles fitting up to 10 x 40 foot space are \$100 for two stickers (add \$40 if vehicle has a slide-out). No vehicles over 40 feet in length will be accepted in the exhibitor overnight parking area. Exhibitors showing Western Horses, Saddle Clubs, Open Beef Cattle, Open Dairy Goats, Poultry and FFA.
