NOMINATION PROCEDURES

Eligibility Criteria

- The nominee must be a resident of Minnesota.
- The nominee's volunteer service must be accomplished **after reaching age 65**.
- Nominee must be **age 70 by June 1 of the current year**.
- Nominee must currently do a volunteer activity that is unpaid and demonstrates commitment to their local community.
- A previous county winner not chosen as the state winner is eligible; however, a current year's nomination form must be completed.
- You may only nominate one individual per nomination form. Couple nominations will be disqualified.

Instructions

Explain why you are nominating this person for the Outstanding Senior Citizen award. It is helpful to give specific, detailed and precise examples to assist the judges in choosing the winners. Do not hesitate to interview the person you are nominating. Nomination does not need to be kept secret. You may also speak to people at the organizations where the individual volunteers. Political and religious organization involvement will only be considered when it benefits the community. All information will be held in confidence by judges. Information submitted is not returned unless a request is made.

Judges will look for:

- Diversity of accomplishments
- How this person has touched the lives of other people in the community
- Total scope of activities, including years of service and time commitment
- Variety of services performed and involvement in organizations
- Quantity of accomplishments and amount of service **after age 65**
- Quality of activities, especially innovative services
- Geographic area covered by their service
- Individuals are encouraged to submit up to three letters of recommendation that focus on the candidate's achievements. **No more than three letters will be used in the judging process.**

The nominations will be judged by three representatives from each of the following organizations: the Minnesota State Fair, the Minnesota State Fair Foundation and the Minnesota Federation of County Fairs.

Instructions for County Fair Outstanding Senior Selection

Appoint a selection committee:

The County Fair should appoint an Outstanding Senior Citizen Award selection committee/person to handle the selection procedures as soon as possible.

Distribute the materials in the packet:

As soon as your county's selection committee has been named, provide members with the appropriate materials in this packet.

Select winners and send winner names to the County Fair:

At the end of a reasonable nomination period, the selection committee should meet and select your county's Outstanding Senior Citizen(s).

Certificates of recognition:

You may want to create a certificate to be presented to your county winners.

Entries must reach the Minnesota State Fair by Monday, August 6, 2018:

The committee must attach the official county finalist form for the county winner and attach the nomination forms (one for each gender), and send them to the Minnesota State Fair by the above deadline. The Selection Committee is encouraged to select one male and one female winner from their county that will go on to compete at the state level.

Only **one male** and **one female** nominee from each county is eligible for this award.

Please remember to send both the male and female Minnesota State Fair Nomination Forms and county winners form.

The State Fair's Outstanding Senior Citizen Award ceremony will be held August 30, 2018. Each of the county winners will be invited to sit on stage during the ceremony, followed by an open house (serving light refreshments) at the JV Bailey House for them and four guests of their choosing. A registration packet with gift items for their day at the fair will be given to each county winner in attendance.

This invitation will not go out until the **WEEK BEFORE THE MINNESOTA STATE FAIR**. The 2018 dates of the Minnesota State Fair are Aug. 23 through Sept. 3.

SENIORS DAY IDEAS FOR COUNTY FAIRS

- To attract a great crowd for your county fair, consider having a Seniors Day. For added incentive, offer free food or admission discounts for seniors. The menu can be very simple and remember seniors will often bring along their sons, daughters and grandchildren.
- Ask an outside group to run your outstanding senior citizens ceremony. Possible sponsors include:
 - Area agencies on aging
 - County volunteers or aging coordinators (usually employees of county social service departments)
 - Civic organizations
 - County committees on aging
 - Local newspapers
- Offer free blood pressure checks or other health services to seniors on Seniors Day. County public health nurses could provide these services free of charge.
- A senior citizens talent contest is fun to hold on Seniors Day. Or you could organize an afternoon of music put on by seniors themselves.
- Contact county 4-H groups and have them offer free beverages on Seniors Day. This could raise awareness of 4-H and encourage inter-generational cooperation.
- Try having a senior citizen booth where senior citizen clubs/organizations could sell homemade crafts and/or food.
- On Seniors Day, hold a recognition ceremony for the winners of the County Outstanding Senior Citizens award and everyone nominated. Include music, speeches, corsages and awards in the program.
- After the selection of the county's Outstanding Senior Citizen(s), check to see if communities are having any parades in which the winning seniors could participate. This is an honor for the seniors and usually welcomed by the parade committee
